Course Description

This course explores European Cultures, by using various scopes and lenses, and different case studies from around Europe. It aims to encourage a critical understanding of both the notion of European, and of culture, as well as their symbiotic co-existence in these terms. Using a multi-disciplinary approach – including historical, sociological, cultural, and anthropological resources – it invites a rounded thinking about European cultures (and cultures in more general terms), and emphasizes the notions of diversity, inclusion, and constant change in Europe and beyond.

The learning outcomes of this course unfold in two levels. On one hand, to introduce the complex notion of culture, in ways that will invite critical understandings of human cultures around the world, and reflections on one's own culture. On the other hand, to introduce the complex notion of European, showing how one understands such contexts only by challenging their uniformity and fixity.
